Volunteer Application Agreement

Volunteer Agreement

In signing this application I understand and agree:

- To attend the required training and to abide by the VVHS Volunteer Program policies and procedures.
- To follow written and oral directives from VVHS staff.
- That I can be terminated from the volunteer program at any time.
- To give VVHS permission to use photographs or video footage of my volunteer activities.
- That this is not a paid position and that I am not an employee of the VVHS.
- To show a copy of my driver's license or Identification card, upon request.
- That if I am under 18 I must have parent consent before I may volunteer at VVHS.

Informed Consent, Release and Agreement to Hold Harmless
